

# Kindergarten Classic Series

## Two-Year-Old for All Sex and Gaits

### Owned & Serviced By:

The Meadowlands

### Sponsored By:

The Meadowlands, et al.

### For:

2-Year-Olds with separate divisions for sex and gait

### To Be Raced As:

A series of preliminary legs with a Final.

### Estimated Purse:

Preliminary Legs: \$20,000

Finals: 2CT & 2FT - \$250,000 .....2CP& 2FP - \$175,000

Consolations: \$50,000

The Final purse for each division shall be 75% of the total of all nomination and sustaining fees paid combined with the added money for each division. The remaining 25% shall be offered for Consolation races for each division. A minimum of six separate wagering interests may be required for the Consolation to be raced. In the event that the Consolation does not fill, 100% of those funds described above will be offered as the Final purse.

### To Be Raced At:

Finals at The Meadowlands and/or other locations on the published dates.

### Cancellation:

The Sponsors reserve the right to cancel any or all races if it becomes impractical or undesirable in the opinion of The Sponsors to conduct said races and the right to change the date and/or the location of the race(s). If an event is not raced, The Sponsors responsibility and liability shall be limited to refunding, without interest, all payments collected toward these events. These monies will be pro-rated among those owners of horses eligible at the time of cancellation.

### Added Money:

Sponsors will add a minimum of \$80,000 in total to these races. These funds, barring any unforeseen circumstance which may preclude this, in addition to all monies paid in by nominating horse-men shall constitute the purses for this event. All entry fees will be added to the leg purses for these events.

### Payments (U.S. Funds only):

Eligibility requires payment as listed below. All payments are forfeits.

### Payment Schedule (per USTA 12.02):

February 15 .....\$300

March 15 .....\$400

April 15 .....\$500

Declaration Fee Legs .....\$250

Declaration Fee Final & Consolation ..... 1% of Purse

### Supplemental Nomination/Declaration:

There shall be no supplemental nomination or declaration to these events.

### Declaration:

All horses must be properly declared for each leg and the final & consolation of the series. All declarations for these events will close at the time and date designated on the condition sheet of the Host Track. Declaration fees are payable to the Host Track and shall be due at the time of declaration and payable before the horse starts. The declaration fee is payable for only the legs of this series in which the nominee participates. There are no refunds for scratched horses. At the time of declaration, horses declared to race in these events must have a past performance line that meets the current qualifying standard for stakes and/or added money races at the Host Track. Any horse eligible via the point standings to race in the final of this event will be considered "Qualified to Race" in the final.

### Notice:

Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event.

### Racing Conditions:

Should more than may be accommodated in a single division declare to start in any leg, the Host Track may adopt any of the methods of dividing the race current in the rules and regulations.

### Special "Win and You're In" Eligibility:

The officially declared winners of the Kindergarten Finals, if they are eligible to the Freshman Fall Final Four stakes as of June 1, 2024, will be eligible to advance directly to the final of their respective division at the discretion of the owner(s). They are also entitled to be put into the post-position draw the same as elimination winners if eliminations are required. They must enter at the prescribed time as all other entries and meet the qualifying standards as outlined in the conditions of the stakes. The entry status is not transferable and only applies in the year of both events.

### Eligibility for Final:

To start in any Final, horses must be declared for that race with the Racing Office by the time posted on the condition sheet. The maximum number of starters in the Final(s) shall equal the number of positions on the starting gate of the Host Track. The point leader(s) at the time of the draw for the final shall draw from post positions 1-6. To be guaranteed eligibility to race in the Final(s), a horse must start in a minimum of 50% of the preliminary legs scheduled in their division.

### Point System:

In the event that the number of horses eligible as provided in these conditions declared into any final exceeds the maximum number specified by these conditions, a point system (listed below), based on the official order of finish: (1) at the Host Track for the applicable preliminary leg and (2) at the time the entry box for the Final is closed, will determine preference for the Final.

1st Place ..... 35 Points

2nd Place ..... 25 Points

3rd Place ..... 15 Points

4th Place ..... 10 Points

5th Place ..... 8 Points

6th Place ..... 6 Points

7th Place ..... 4 Points

8th Place ..... 2 Points

9th Place and all other starters ..... 1 Point

### Dead-Heat:

Any horses finishing in a "Dead-Heat" for any position will be awarded an equal share of the total number of points for the positions involved in the "Dead-Heat".

### Tie Breaks:

First, the horse(s) with the most starts in the preliminary legs of this series shall receive preference and if after that a tie remains, then: The horse(s) with the highest total earnings to date in the current season as compiled by the USTA shall have preference.

Any horse entering a designated point earning series event which does not fill and is not raced will receive SEVEN (7) points towards qualifying for the Final, plus credit for a start toward fulfilling any minimum number of starts requirement and toward tie-breaker "a" regarding eligibility for the finals. A horse scratched from an event, which is raced, will NOT receive credit or points toward meeting the starting requirements for the Final.

### Starters in Fewer Than Two Legs:

All horses must be declared for the Final by declaration time. Notwithstanding any of the above conditions requiring a minimum number of starts in series legs, in the event a Final fails to fill to the extent as described in the above condition, those with fewer than the minimum starts that declare will then be considered for inclusion in the Final. The highest point earners in this group shall have preference in being added to the field, and in the event of ties, the above clause(s) will be used. Horses must be credited with at least one start in the series to be eligible to the Final.

### Money Division:

Leg purses shall be left to the discretion of the Host Track. One percent (1%) of the purse for the Final & Consolation will be paid to each horse finishing sixth through last. The Administrator will deduct 1% of the total of nomination and sustaining payments to cover the cost of administration, trophies, and trophy coolers for this (these) events.

The balance of the Final & Consolation purse shall be distributed 50% - 25% - 12% - 8% - 5%..

### Standards for Participation:

**A. Owner/Trainer Ineligibility:** Any owner(s) or trainer(s) whose conduct falls within the conditions forth set below shall be ineligible to participate in any of the races or events owned, sponsored, conducted, or serviced by New Meadowlands Racetrack:

- (1) Any owner(s) or trainer(s) who has been convicted, arrested, indicted or is the subject of a publicly disclosed government criminal information, the subject of an investigation by a government regulatory agency or is the subject of any internal investigation conducted by The New Meadowlands Racetrack ("proceedings"), which proceeding(s) finds, determines, suspects, investigates, involves or charges such owner(s) or trainer(s) with administering, purchasing, selling, encouraging the sale of, manufacturing, distributing or using prohibited drugs or prohibited performance enhancing substances, and/or;
- (2) Any owner or trainer who has been or is the subject of a proceeding, which proceeding(s) finds, determines, suspects, investigates, involves, or charges such owner(s) or trainer(s) with the illegal or unethical treatment of animals.

**B. Horse Ineligibility:** Any horse(s) owned or trained by person(s) or entity(s) that is deemed to be ineligible under section A above, shall likewise be deemed ineligible to participate in any events or races owned, sponsored, conducted, or serviced by The New Meadowlands Racetrack.

**C. Stakes Payments & Forfeiture:** Stakes payments, whether initial or sustaining, made for the participation of horse(s) deemed ineligible under the above, shall be void and forfeited by the participant at the sole discretion of The New Meadowlands Racetrack, with no liability or obligation to The New Meadowlands Racetrack, and without any assurance by the New Meadowlands Racetrack that a refund or reimbursement of such payment(s) will be made by The New Meadowlands Racetrack despite such stakes payments having been previously made for and to the stake/event in question.

**D. Ineligibility Period/ Transfer of Ownership:** The ineligibility of an owner(s), trainer(s) or horse(s) Section A or B above shall commence upon a conviction, arrest, indictment, criminal information, government regulatory investigation and/or internal investigation and continue, in the discretion of The New Meadowlands Racetrack: (1) until such time as The New Meadowlands Racetrack is satisfied that the owner(s) or trainer (s) who is the subject of a proceeding(s) as described above, has been determined to have not engaged in such conduct as would render the owner(s) or trainer(s) ineligible under Section A or B; or (2) when there has been accomplished and perfected, supported

by appropriate and confirming verifiable documentation, the transfer of ownership of the horse and/or the change of owner(s) or trainer(s) from an owner(s) and/or trainer(s) deemed to have been ineligible under Section A or B above, to a bona fide separate and unrelated licensed eligible owner(s) or trainer(s).

**E. Opportunity to Provide Relevant Information:** The New Meadowlands Racetrack will afford an owner(s) and/or trainer(s) the opportunity to present personally and on a timely basis to the management of The New Meadowlands Racetrack, any information, documentation, evidence, or argument to counter, disprove, or contradict any finding or other information which forms the basis for any conviction, indictment, arrest, criminal information, governmental regulatory investigation or internal investigation upon which The New Meadowlands Racetrack relies for determining any owner(s), trainer(s) and/or horse(s) to be ineligible to participate in a race or event sponsored or conducted by The New Meadowlands Racetrack. In such case, and without any commitment to do so, The New Meadowlands Racetrack may in its sole discretion reconsider its determination on the ineligibility of any owner(s), trainer(s) or horse(s) to participate in any race or event sponsored or conducted by The New Meadowlands Racetrack.

### Rules:

A minimum of seven (7) separate interests may be required in any event or the event may be cancelled. All starters are subject to the detention policy of The New Meadowlands Racetrack. These races are subject to the Stallion Restriction Condition (SRC) see Meadowlands website for details. The choice of drivers for this event will be limited to those drivers who have applied and are approved to drive in Meadowlands races. A list of approved drivers will be available from the Racing Office. Any horse nominated to any Meadowlands stakes/event must be in the care of an approved trainer by April 15 year of the stake for any stake/event raced during the month of May and May 15 for all other stakes/events. In addition, any owner who participates in a Meadowlands Stake or Early Closing event (with added money greater than \$25,000) with a trainer who has an outstanding Class 1, Class 2 or TC02 positive test having occurred on or after January 1, 2019 and under appeal in any jurisdiction will be declared ineligible to participate in any Meadowlands Stake or Early Closing event for 12 months following the conviction if such trainer is subsequently found guilty relating to the Class 1, Class 2 or TC02 positive test. Nominator also agrees that any horse paid into any Meadowlands stake/event may be required to be stabled for up to 14 days at an approved facility within a 150-mile radius of The Meadowlands or Tioga or Vernon Downs or an approved facility in a state that agrees to cooperate in an out of competition testing protocol by the date set by The Meadowlands for that stake/event for the purpose of out of competition testing.

### Disputes:

All owners, trainers and drivers of horses nominated to this event must be accepted to participate at the Host Track or the nomination/entry may be denied without refund of previous payments. Any change of trainers made fewer than 30 days or within four starts of the date of this race will be reviewed by the sponsor and if not accepted, may result in refusal of entry. Sponsors reserve the right to amend conditions as deemed necessary without liability. A nomination to these events is an agreement to the above terms and conditions.
