May 15, 2018 (subject to USTA Foaling date rules).....\$15

**Late Nomination Payment:**

Dec. 15, 2018.....\$50

**Late Nomination as a 2-year-old**

Feb. 15, 2019 .....\$75

**Sustaining Payment:**

Colts and fillies as 2-year-olds (foals of 2017)

March 15, 2019 .....\$50

(March payment must be made to remain eligible as a 3-year-old.)

**Late Supplemental Fee:**

March 15, 2019 including sustaining fee .....\$250

**Sustaining Payment:**

May 15, 2019 .....\$50

**Sustaining Payment:**

Colts and fillies as 3-year-olds (foals of 2017):

Feb. 15, 2020 .....\$50

April 15, 2020 .....\$50

Declare in to race by 10:00 a.m. 3 days prior to race date (3 day box.)

**Starting fee:**

Two-year-old .....\$200

Three-year-old .....\$100

**2019 Actual Purses:**

3-Year-Old Pace.....\$12,450

3-Year-Old Trot.....\$9,100

**To Race At:**

Great Darke County Fair, Greenville, Ohio.

All money received in nomination fees and payments plus the amount received from the track awarded these stakes will be paid out in purses less actual expenses (ie., clerical, printing, postage). All Money paid on 2-year-olds with the exception of the starting fees and May 15, 2018 yearling payment will be divided equally between the Trot and the Pace. All payments on 3-year-olds will be credited to the division according to the declared gait of the colt/filly. If any 2- or 3-year-old changes gait at any time, it may be transferred to the race to which gait has been adopted at any payment date including the starting fee payment and all payments follow that race, except where they are divided equally. All events will be raced in a single dash of one mile. Money division will be 50-25-12-8-5%. No purse money set aside for the winner. Trophy for each division. If more than nine are declared into start, race will be divided. At the discretion of the Judge, fillies and colts can be raced separately based on number of entries.

**Purse Distribution:**

In the event there are less than five starters in any event, the purse will be distributed as follows:

Four starters: 55-25-12-8%

Three starters: 60-28-12%

Two starters: 65-35%

One Starter: 100% but horse must start and go over the course.

No entry fees to be returned on a declaration after a horse has officially been declared to start. If any condition, beyond the control of the Association arises which prevents the racing of these stakes, or any division thereof, the right is reserved to call same off and pay the persons owning the colts/fillies on grounds eligible at the time of said calling off, their prorated share of all money which has accrued in the division or divisions called off, after deducting the actual expenses of the Association.
