Race Conditions:

- 1. Starting fee of \$500 for eliminations due at a prescribed time and date. There is no starting fee for the final. There will be no refunds for any scratched horses. Colts & geldings not eligible, may supplement for one payment of \$10,000 due at a prescribed time and date.
- 2. Purse Distribution: 50% First, 25% Second, 12% Third, 8% Fourth, 5% Fifth (Dead Heats will be divided evenly)
- 3. Each race to be held at One Mile dashes. Post positions for all races will be drawn by lot. The final will be limited to eight starters; also eligibles will be programmed for the final. However, if the also eligible would create an entry as determined by the NYS Gaming Commission, the next eligible horse will be the also eligible. Elimination races will be held no less than six days prior to the final. One charted line meeting Yonkers Raceway qualifying standards will be required.
- 4. If 2 Divisions: The first four finishers in official race order will return for the final. If 3 Divisions: The first two finishers in official race order and the two third place finishers with the fastest individual times in official race order will return for the final. If 4 Divisions: The first two finishers in official race order will return for the final. If 5 Divisions: The five winners and the three second place finishers with the fastest individual time in official race order will return for the final. If there ever exists a need for six or more divisions, eligibility to the final will be determined in a manner consistent with the published conditions. In the event of a tie, the starter will be determined by lot; however, a non-entry horse will have preference over a horse creating an entry.

- 5. Post Positions for all races will be drawn by lot. Horses making the Final will automatically be entered by the Race Secretary.
- Yonkers Raceway reserves the right to refuse any horse, trainer, driver and/or owner to race in this event.
- 7. New York State Gaming Commission and Yonkers Raceway General Rules and Procedures will govern these events.
- 8. Should circumstances prevent the racing of these events monies paid in will be pro-rated among the owners of remaining eligibles of the uncontested race or races at the time of declaring off.
- 9. If there are less than 24 horses after the sustaining payment Yonkers Raceway may cancel the race. Payments will go to the owners of the remaining eligible horses.
- 10. Judges official order of finish will be used in determining eligibility to the Final events, exclusive of all appeals yet to be decided at the time of declaration to the Final events. In the case of a positive drug test, all appeals will be excluded from eligibility to final events until they are resolved by adjudication.
