**To Be Raced At:**

Delaware, Ohio, during Grand Circuit week in 2020

**For:**

Foals of 2018. (Subject to USTA Foaling Date Rules).

**To Be Raced As:**

Four races. Open and Filly divisions for 2-year-old trotters and pacers.

**Added Money:**

\$6,000 will be added to each Open division by the Delaware County Fair.

\$6,000 will be added to each Filly division by the Delaware County Fair.

**Estimated Purse:**

**Nomination Fee:**

May 15, 2019.....\$25

**Late Nomination Fee:**

**Special Notice to Foreign Nominators:**

Nominators shall be active members of the USTA and the yearling must be properly identified to the satisfaction of the USTA at the time of nomination.

**Future Payments for Colts and Geldings (U.S. funds only):**

Supplemental Fee - March 15, 2020 ..... \$200  
March 15, 2020 ..... \$400  
Starting Fee ..... \$1,000

**Future Payments for Fillies (U.S. funds only):**

Supplemental Fee - March 15, 2020 ..... \$200  
March 15, 2020 ..... \$300  
Starting Fee ..... \$1,000

**Supplemental Payment:**

Two-year-olds not nominated in the May 15 yearling payment may be made eligible through a supplemental nomination fee of \$200 due on or before the March 15 payment. This supplemental payment is in addition to the normal March 15 payment.

**Starting Fee:**

Due by 10 a.m. three days before date of race. (Sundays counted)

**Filly Notice:**

Fillies may transfer to the open race at time of declaration by paying an amount equal to the total required for colts. Previous payments remain with the filly race. A filly may not declare or enter in both events.

**Transfer:**

Eligible changing gait may be transferred at any time. Payments already made remain with the original gait.

**Payment Distribution:**

Nomination fees will be divided equally among the four races. Other payments will be credited to the specific race.

**Racing Conditions:**

Each event to be raced in divisions at one mile each. The horse with the fastest time will receive the trophy. Purses will be divided equally into two parts with money division 50-25-12-8-5% each heat.

**Notice:**

USTA Rule 12, Section 4 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event." The Delaware County Fair will construe payment to require that cash or check duly honored upon presentation to be received at the time specified in USTA Rule 12, Section 2. If a check is not duly honored upon presentation, the horse becomes ineligible to race, or if it races, to participate in the purse.

**Rules:**

This track is licensed by the State of Ohio Racing Commission and operates under the rules of the State Racing Commission in conjunction with the United States Trotting Association. The Delaware County Fair will have the final decision on all matters pertaining to the racing of these stakes.
