POSITIVE TEST- POST RACE

CODE 58-183.352 183.354 183.355 183.357 183.336 Sample #293615 collected on 8/19/2015 from the horse Powerful Yield tested positive for Cobalt. Arlene Cameron as trainer is in violation of PHRC medication rules and the trainer responsibility rule. Ms. Cameron has also violated her Conditional Licensing Agreement. All purse money earned on 8/19/2015 must be returned within 10 days of ruling and redistributed. Transfers of all

horses must be approved by the Judges at Harrah's Chester or by the PHRC. All Fines must be paid within 10 days of ruling. This is the 4th positive test for the Trainer in 2015. All Fines must be paid within 10 days of ruling. Please note that you have the right to appeal this decision in writing to the PA Harness Racing Commission within ten (10) days after notice of this decision as set forth in 58 Pa. Status as of 4/4/2016 - Subsequent Ruling - RULING# 16021C Horse Racing Commission, Bureau of Standardbred Racing, and Arlene E. Cameron, and in consideration for her withdrawal of Chester Downs' judge's ruling No. 15104CD and ruling No. 15148CD, the rulings are hereby modified as follows: Ms. Cameron will serve a combined forty-five (45) day suspension beginning 08 April 2016 thru and including 22 May 2016. Ms. Cameron will also pay a combined fine of two-thousand five-hundred (\$2,500.00) dollars which must be satisfied by 22 May 2016. The horses "POWERFUL YIELD" and "BWT TAG" remain disqualified from their respective races at Chester Downs' and any and all purse money must be returned no later than 22 May 2016.

substances, unsecured in your stabling area, including the following foreign substances: Cobalt, Stanozolol, Zinconotide (SNX-III), Chlorpromazine, Flunixin, Hyluronate Acid, Gamma-Aminobutyric Acid (GABA), Phenylbutazone, Tripelennamine, Methocarbamol, glycopyrrolate, Dexamethasone, Guaifenesin, Furosemide, Flumethasone, Hydrochlorthiazide, and Trichlormethiazide.

Status as of 3/21/2016 - Subsequent Ruling - A request for an appeal and a stay is hereby denied.

After consideration, the stewards find trainer Ervin Miller in violation of IRB rule 603.30 (A) and subject to a civil penalty of \$500 for being the trainer of record of GOINGDUNESIDE on aforementioned date.
