### **POSITIVE TEST- POST RACE**

Trainer Leigh A Raymer, being trainer of record for sample #H-04960 dated February 28, 2017 which tested positive for diazepam. A split sample was sent to PA Equine Toxicology & Research Laboratory on March 27, 2017 and was returned positive for diazepam (class 2) on April 27, 2017. According to ARCI, diazepam is considered a class 2 violation, penalty B. After a judges hearing on March 22, 2017 and a second hearing on May 2, 2017, the judges considered mitigating circumstances and fined trainer Leigh Raymer \$3000.00, loss of purse (\$4500.00) and issued a 60 day Full Suspension of her DHRC license. Golden Idol finished 1st and is disqualified. DHRC rules: 3.2.3.7.2; 5.3.2.1; 3.2.3.10; 3.2.3.11; 8.3.2.2; 5.1.7; 8.3.2.6. All horses of a trainer issued a full suspension shall not be transferred for the purpose of training to a spouse, family member, assistant, current employee/employer, or household member. DHRC rule: 10.2.8.3. All fines are to be paid within 10 days of written rule.
