Urine sample #868168 collected at Northfield Park on 3/17/18 from the horse Threefold Breanna was found to contain Methocarbamol at a concentration of 2.8+-0.1 micrograms per milliliter of urine. This exceeds the Regulatory Threshold of 1.0 micrograms per milliliter adopted by the OSRC. All purse money must be returned for redistribution (\$2,500.00). Vincent Bradley, being trainer of record on "GOIN DOWN ROCKIN", is fined \$2000.00 and GOIN DOWN ROCKIN is placed on the Judge`s List for 14 days for failing a pre-race test on April 9, 2018. Any horse that tests at a level over 12.3 Base Excess Level with Lasix is positive and is declared unfit to race. GOIN DOWN ROCKIN tested at a Base Excess Level of 12.8 mmol/L and at 12.7 mmol/L second test. DHRC rule: 8.9.14.2.1; 8.9.14.2.3. After 14 days GOIN DOWN ROCKIN must pass a blood gas test and re-qualify to compete in purse events. DHRC rule: 8.9.15.1.1; 8.9.15.1.2. This

PA Code 58-183.345(a) 183.344 While on the backstretch on 4/10/18 he did intend give give his horse a liquid mixture to his horse who was racing that evening. He did not give it to the horse as the investigators showed up and saw him with a dose syringe ready to put in the mouth of the horse. Both of his horses(Love Forbidden and Believeinthspirit were scratched). The investigators then started a search of his area and vehicle and also of his person. Mr. Dowdall failed to cooperate with the investigators when asked to show them what he had in his sweater pocket. He 1st pulled out a cell phone and then put his hand back into his pocket. When asked what else he had in his pocket, he refused to take his hand out of his pocket or turn the pocket inside out. Mr. Dowdall is fined \$1000.00 and is suspended(full)15 days starting on May,3rd 2018 and continuing through May, 17th 2018. Mr. Dowdall may not transfer any horses he owns or trains without the approval of the judges at Pocono Downs or with The State Horse Racing Commission. During this suspension he and all horses owned and trained by him are barred from all tracks under the jurisdiction. POSITIVE TEST- PRE RACE

PA Code Title 58-183.336,183.351,183.355,183.357. Mr. Sullivan was the trainer of record for the horse THISWAYORTHEHIGHWAY, which was programmed to race in the 5th Race at The Meadows on April 21, 2018. THISWAYORTHEHIGHWAY failed the pre-race blood gas test, and was scratched. Mr. Sullivan, as the trainer, is hereby fined \$1,000 and issued a 30 day full suspension of his license in Pennsylvania beginning May 5, 2018 through and including June 3, 2018. During the term of his suspension, Mr. Sullivan is ruled off all grounds under the jurisdiction of the PSHRC. Any trainer transfers of horses in his stable must be approved by the Judges at The Meadows. Mr. Sullivan has 10 days to appeal this decision to the PSHRC, Bureau of Standardbred Racing.
