Joseph Ciuffetelli was the programmed trainer of the horse AVENTURE when it competed in the 3rd race on Friday, April 5, 2019. The horse, AVENTURE, finished 2nd in the 3rd race on Friday, April 5, 2019 and was post race tested with a blood sample drawn for analysis. The blood sample collected from the horse AVENTURE on Friday, April 5, 2019 identified the presence of the prohibited substance Methocarbamol. The presence of Methocarbamol in the horse AVENTURE is in direct violation of the New Jersey Racing Commission rule N.J.A.C.13:71-23.1. Consistent with N.J.A.C.13:71-23.7, the horse AVENTURE is hereby disqualified from sharing in the purse from the 3rd race on Friday, April 5, 2019. The purse is hereby ordered to be redistributed among the remaining finishers.

They also own a horse together and Ms. Doreen Dailey helps out with Ms. Danielle Dailey`s horses whenever she can. There are no other trainers in the barn with Ms. Doreen Dailey and Ms. Danielle Dailey. Ms. Doreen Dailey in the investigation of the claim said she put in a claim for her new owner open claimant Stephanie Davis after learning of another trainer entering a claim on #10 ROCKAHOLIC. Ms. Doreen Dailey s hereby suspended for a period of 30 days from May 6, 2019 and through and including June 4, 2019. Ms. Dailey is also fined the
